We refer to your submission of draft Scheme of Amalgamation filed by Asutosh Enterprises Limited, filed under Regulation 37 of SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015 and in accordance with SEBI Circular No. CFD/DIL3/CIR/2017/21 dated March 10, 2017.

Subsequent to the examination by SEBI, it is noted that one of the company i.e. Asutosh Enterprises Limited has not applied for registration as NBFC under Section 45-1A of the RBI Act, 1934 and is wrongfully disclosing in its financial statement regarding having applied for registration as an NBFC. Further, the company is conducting NBFI activities without holding a certificate of registration issued by RBI, which is in violation of RBI Act, 1934.

In view of the aforesaid, SEBI has returned the draft scheme. Copy of the SEBI letter dated January 28, 2020 is attached as **Annexure I**.

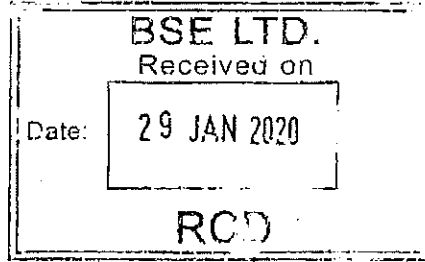

Further, as intimated, the company is conducting NBFI activities without holding a certificate of registration issued by RBI, which is in violation of RBI Act, 1934.
